In consideration of these rights, I hereby release the following from any liability, claims and causes of action connected with my participation: (a) the club and its Directors, Instructors, Monitors, Members and Agents, and (b) the Sun Lakes Country Club, Cottonwood/Palo Verde and Oakwood/Ironwood Homeowners Associations and their managements.

As a responsible member of the club ---

- I agree to pay the required fees for membership, activities, instructional classes, and shop use.
I understand that Instructors, Monitors and Activity Coordinators are in charge.
I understand that while using any of the SLRGS shops I must comply with the monitor or instructor on duty.
I will only use the shops during the designated times unless I have the permission of the instructor or monitor on duty.
I will use club equipment, tools and materials only as intended and only after satisfying applicable prerequisites.
I will pay for the repair or replacement of any equipment or tools which I damage through improper use.
I will observe all SLRGS SAFETY PROCEDURES.
I will clean up equipment, tools, and work areas after I have used them.
I will comply with all club rules, requirements and regulations and understand that failing to do so may result in cancellation of my membership.

I assume all risk in connection with my personal club activities. This document will serve as a release and indemnity agreement for my heirs, personal representatives, and all family members. I further state that: I am at least eighteen (18) years of age; I am legally competent to sign this release; I understand these terms are contractual; and I have signed this document as my own free act of agreement to all conditions stated herein.
